C.1 End of Day - Import Food Instrument File

The Food Instrument import file contains WIC and/or Farmers Market food instrument issuance data in an XML format.

This business rule allows SPIRIT to indicate that the End of Day Process will automatically import the Food Instrument data file.

SPIRIT is implementing the Vendor, and WIC systems with the exact same food instrument issuance information. The issuance information will be automatically synchronized among the three programs without the need for a Food Instrument data file. Therefore this business rule will be set to No (N) for SPIRIT.

C.7 End of Day - Process 3 Month Rolling Average for Peer Group Pricing
