## K - Risk Factors

### K.1 Risk Factors Panel

The Risk Factors panel allows the user to view the current and past certifications for a participant, as well as the risk factors associated with the certification.

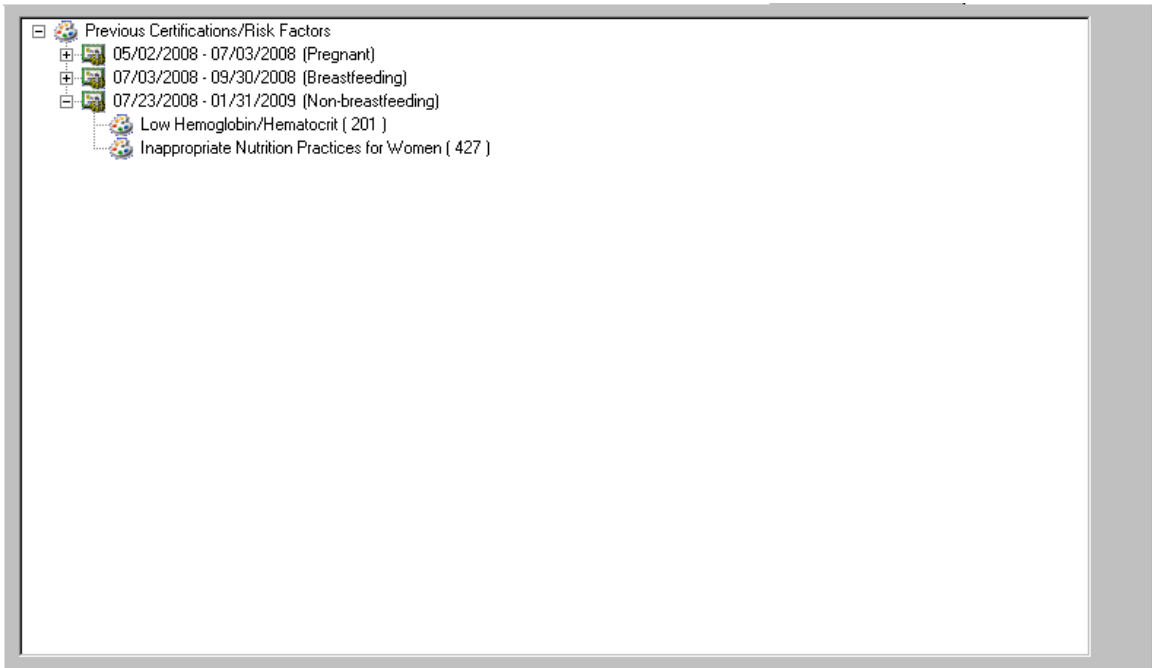


Figure 1 - Risk Factors Tab

#### K.1.1 Controls

This section describes the behavior of the controls on the Risk Factors tab of the Participant Folder.

##### K.1.1.1 Risk Factors Display Tree View

This control allows the user to view the WIC certifications for the participant along with any associated risk factors. The tree view will be enabled when the dialog is active. It will consist of the following hierarchical structure:

It will be filled with all previous certifications for the participant. They will display in chronological order. The data values on the tree view will be read-only.

#### *K.1.1.2 Certification Period Tree View Node*

This node of the Risk Factors Display tree view allows the user to view the certification periods for all previous certifications of this participant. The node will consist of an appropriate icon and text in the format of {certification effective date (MM/DD/CCYY) - certification end date (MM/DD/CCYY)}. The certification period closest to the current system date will default to expanded. All other certification period nodes will be collapsed.

The node will also include the participant's WIC Category in parentheses at the time of the certification period (i.e. "(Pregnant)", "(Breastfeeding)", etc.). The node will consist of an appropriate icon and text in the format of {certification effective date (MM/DD/CCYY) - certification end date (MM/DD/CCYY) (WIC Category)}.

#### *K.1.1.3 Risk Factor Tree View Node*

This node of the Risk Factors Display tree view allows the user to view the risk factors associated with the certification period. The node will consist of an appropriate icon and text in the format of {Risk Factor description} ({Risk Factor code}).

### **K.1.2 Processes**

This section describes the processes (navigation) that take place as a result of the actions taken on the Risk Factors tab.

#### *K.1.2.1 Initializing the Interface*

Upon initial display of the tab:

- The Risk Factor Tree View Node will display the risk factors associated with the certification period. The node will consist of an appropriate icon and text in the format of {Risk Factor description} ({Risk Factor code}). The data map for the Risk Factors tree view is defined in [Clinic Chapter 10 - Certification Guided Script](#).
- The Risk Factors display tree view displays all risk factors in chronological order by certification date for the selected participant.

#### *K.1.2.2 Edits*

There are no updateable controls on the Risk Factors tab; therefore, there are no required controls.

### *K.1.2.3 Saving the Data*

There are no updateable controls on the Risk Factors tab; therefore, no data is written to the database.
