<b>PRODUCT DESCRIPTION</b>	<ul style="list-style-type: none"> <li>This shelf stable milk is made from grade A fresh milk which has been fortified with vitamins A and D.</li> <li>It has been processed using a method called Ultra High Temperature (UHT) which destroys bacteria, while preserving the flavor, taste, and nutritional value of the milk. This process requires no refrigeration until the container has been opened.</li> </ul>
<b>PACK/YIELD</b>	<ul style="list-style-type: none"> <li>27/8.0 oz units per case.</li> <li>Each individual unit provides 8.0 fluid oz of milk.</li> <li>CN Crediting: 1 individual unit (8 fl oz) 1% UHT milk provides 1 cup or ½ pint milk. Please refer to FNS Instruction 783-7, Rev. 1 on State/local standards for fluid milk.</li> </ul>
<b>STORAGE</b>	<ul style="list-style-type: none"> <li>Unopened shelf stable milk can be stored without refrigeration for about six months off the floor in a cool, dry place.</li> <li>Use First-In-First-Out (FIFO) storage practices to ensure use of older product first.</li> </ul>

<b>PREPARATION/ COOKING INSTRUCTIONS</b>	<ul style="list-style-type: none"> <li>• Shake well before opening.</li> </ul>
<b>USES AND TIPS</b>	<ul style="list-style-type: none"> <li>• Shelf stable milk may be used in cooking and as a baking ingredient like regular milk, but it is often enjoyed as a beverage or over cereal.</li> <li>• May be served as at room temperature, but it best served chilled.</li> </ul>
<b>FOOD SAFETY INFORMATION</b>	<ul style="list-style-type: none"> <li>• Check best if used by date before use.</li> <li>• Once the container has been opened, it should be refrigerated like regular milk. Keep milk tightly sealed in its original container and consume within 5 to 7 days.</li> </ul>
