Dear State Directors:

The Child Nutrition and WIC Reauthorization Act of 2004 (P.L. 108-265) amended Section 22 of the Richard B. Russell National School Lunch Act (NSLA), to establish a requirement that State agencies conduct additional administrative reviews (AARs) of selected local educational agencies. It also amended Section 7 of the Child Nutrition Act to provide funding for States to conduct administrative reviews and provide training for local educational agencies. These requirements are focused on school food authorities (SFAs) which have demonstrated a high level of, or a high risk for, administrative error.

To assist State agencies in achieving these requirements, the Department of Agriculture Food and Nutrition Service (FNS) will provide funding for Administrative Reviews and Training Grants (ART). The grant funds will be available only to the 57 State agencies that administer the Child Nutrition Programs for the purpose of conducting AARs of SFAs that have demonstrated a high level of, or a high risk for, administrative error.

Since 2009, FNS has announced application opportunities for two types of ART grants. Method I ART grants provide funding for additional administrative reviews and Method II ART grants provide funding for training and oversight activities. This announcement describes the Fiscal Year (FY) 2013 Method I grant application process. Information pertaining to Method II grants will be issued later in FY 2013.

The goal of the ART Method I Request for Applications (RFA) for grant funding is to encourage and support State agencies in their efforts to decrease administrative errors by conducting AARs of those SFAs that may have a high level of, or a high risk for, administrative error. This RFA seeks applications for funding to conduct AARs of high-risk SFAs and a plan for reviews that would be conducted to address these errors. The requirement for AARs is described in FNS memorandum SP18-2013 which can be found on the FNS public website (<http://www.fns.usda.gov/cnd/governance/policy.htm>) or on the Agency's PartnerWeb (<https://www.partnerweb.usda.gov/communities/cndpolicy2/Lists/Whats%20New/Attachments/568/SP18-2013s.pdf>).

State agencies interested in obtaining funding under ART Method I should review the attached Request for Applications (Attachment A), and complete the attached template (Attachment B), and other required forms, as explained in the RFA. Please refer to the full RFA for a complete list of required documents. Funding of up to \$3,500 per review may be requested. If a State agency requests more than \$3,500 per review, appropriate justification must be provided to enable FNS to determine whether the increase is justifiable. All allocated costs, including indirect costs, must be actual and documented.

Applications must be received via www.grants.gov no later than **11:59 p.m. Eastern Standard Time on March 15, 2013**. Applications received after this date and time will not be considered. We strongly recommend that State agencies submit the online application two weeks before the application deadline in case there are problems with the website.
